Parents and Children Together (PACT): A parent delivered early language enrichment programme for pre-school children

School information sheet

[Insert LA information e.g. Lancashire County Council] have teamed up with researchers at the University of Manchester and Durham University for a new research project funded by the Education Endowment Foundation (EEF). This project will evaluate a parent-delivered early language teaching programme for preschool children called Parents and Children Together (PACT). The research team are looking for maintained school teacher led nursery schools/classes with 3-4 year old children to participate in this research project. This information letter provides an overview of the project and outlines how schools can be involved in this work.

Background

Oral language skills provide the foundation for formal education and play a significant role in learning to read. Children who experience delays in early language and communication development are at risk of problems learning to read, and of broader educational disadvantage. Finding ways to support early language development in the pre-school years



has considerable potential to support better educational outcomes for children.

Parents and Children Together (PACT) is a language teaching programme for preschool children that parents deliver to their child at home. This programme has been shown to support children's early language and emergent literacy skills. This project will further evaluate the benefits of the PACT programme for children and families in nursery schools/classes in your area.


Who will we evaluate the programme with?

We will work with 40-45 nursery schools/classes in (N) Local Authorities (LA) in the North-West. We aim to recruit 400-450 children and their parents to take part in the project. We are looking for children who will be 3 years old by September 2019, and who will start school in September 2020. Parents taking part need to be able to speak and read English to a sufficient level to be able to access the teaching materials.

How will we evaluate the programme?

The teaching programme will be evaluated in a Randomized Controlled Trial (RCT). Children and their parents will be randomly allocated to one of two groups: PACT or Comparison. The PACT group will receive the PACT language teaching programme. The comparison group will continue as normal, and will receive a box of children's storybooks at the end of nursery.

It is important that we randomly assign children to PACT or comparison groups so that we can objectively assess the effect of the programme on children's development. To test this, we will use standardised measures of early language and emergent literacy skills. Children will be assessed three times during the project: September-October 2019 (pre-test), June/July 2020 (post-test), and May 2021 when the children will be in Reception (delayed post-test).









As part of the project evaluation, Durham University will observe training and celebration events and will ask nursery school staff to fill in surveys at the start and end of the project. They will also interview a small selection of school staff.

What does the teaching programme involve?

The PACT language teaching programme was developed by a team of psychologists who have expertise in language and literacy development, and the development and evaluation of interventions to support language and literacy skills. The programme supports language development by working on 3 key components: Shared reading, Vocabulary and Narrative (storytelling).

PACT session: 20 minutes				
Introduction	Settle your child	2 minutes		
Reading together	Read the book together and talk about the story	5 minutes		
Vocabulary	Talk about new words and what they mean	5 minutes		
Stories	Talk about what happens in the story	5 minutes

Parents are trained by the research team to deliver the teaching programme to their child at home, in daily 20-minute sessions (5 days per week). Parents and children are given all the materials and resources they need to work on the programme for 30-weeks. The materials are published by Book Trust, and are designed to be easy to use, engaging, and motivating for young children.

What would taking part involve for schools?

We will work with nursery schools to: 1) Identify one member of staff in each school to act as the PACT lead; 2) Hold parent recruitment events, parent training and support sessions, and children's assessments in the school; and 3) Provide childcare provision at the nursery during parent training events (if necessary).

PACT project leads will be asked to: 1) Attend 1-day training to enable them to support the project; 2) Work with the project team to recruit 10-20 children and their parents to take part; 3) Arrange and participate in parent training and support parents who are delivering the teaching programme; 4) Liaise with the research team to organise children's assessments; and 5) Collect routine information from parents and return this to the research team. Schools will need to communicate regularly with the research team and support them to collect information from parents and organise assessment, training and celebration events.

Schools will not need to pay anything to take part. Participating schools will be given £500 at the end of the project to thank them for taking part.

What are the benefits for schools?

LA Early Years and Children's services, and nursery schools play a key role in providing direct support for children's development, and in engaging parents in their children's learning. Involvement in this work will require time and commitment from school staff but will offer considerable potential benefits. Participation in this project will provide schools with measurable evidence to support their service provision and impact. PACT leads in each school will receive high-quality training from the research team in the delivery of a theoretically-motivated teaching programme to support language and communication in preschool children, and in ways of supporting parents to deliver teaching. We will provide schools with feedback on children's outcomes at the end of the project.

What is PACT?

Parents and Children Together (PACT) is a language teaching programme that parents work on with their child at home to help their child:

- Learn lots of new words and how they work in sentences
- Listen to and talk about stories.
- Understand and tell stories
- Enjoy books and reading



PACT is a 30 week programme that parents and children work on every day (5 days a week) for about 20-minutes. In the programme, you will share storybooks with your child, talk about words and their meanings, and tell stories together.





What is the purpose of the research project?

Children's early language and communication skills can make a big difference to how well they learn when they get to school. PACT aims to develop these skills. This research project will test the benefits of the programme and see how parents use it in the year before children start school.

Who will conduct the research?

Why have I been chosen?

The research team are working with nursery schools in your local area on this project. We are looking for 400-450 three year old children to take part with their parents.

Who can take part?

Children who will be three years old by September 2019 and due to start school in September 2020 can take part in this project. Because the teaching programme is written and delivered in English, parents/carers need to be able to speak and read English to participate. Any adult in the family can be trained to deliver the programme. At this stage, we aren't able to include children who have a diagnosed developmental or learning difficulty. We are also unable to include families with siblings in the same year group in this research project.

What happens next?

If you decide to take part in the project, you and your child will be placed in one of two groups: 1) the PACT group OR 2) the comparison group. Parents and Children Together (PACT) is a language teaching programme for pre-school children that parents deliver to their child at home. Children were first assessed in nursery in September 2019 (pre-test). We planned to see children again at the end of nursery in June 2020 (post-test), but

unfortunately we could not do that because of the UK lockdown.

What would my school need to do?

In order to evaluate PACT, we need to assess the language skills of those children taking part in the project. Due to COVID-19 restrictions we are unable to send researchers into school to assess children as originally planned. Instead, we are asking your school to complete an App-based language assessment called LanguageScreen (see https://languagescreen.com/) with the children in the project in June/July 2021. The assessment is delivered on a tablet and can be administered by any adult in school, e.g. a Teacher or Teaching Assistant, without needing additional training. LanguageScreen takes approximately 10 minutes to complete per child. We are also asking for each child's key worker to complete a short (5-minute) online school readiness questionnaire for each child in the project. Schools will be provided with full information and resources to be able to complete these assessments.

Your support in collecting this data is vital to the research which our schools, parents, and the children, have all worked so hard on, and will let us understand whether doing PACT has made a difference to children and families who did the programme.

Appendix F: Construction of pre- and post-test variable

Applying a confirmatory factor analysis (CFA) model in MPlus (version 8.6), a latent primary outcome (post-test continuous score) variable was constructed from the four sub-items of LanguageScreen (RV; EV, LC, and SR). Similarly, a pre-test latent variable was constructed using the baseline measures (CELF Sentence Structure, CELF Expressive Vocabulary, BPVS-3, APT information and Listening comprehension). Initially, all six candidate variables including the APT grammar test scores were included in a CFA model, but this model fit was poor. The final model for the pre-test latent variable retained five variables (CELF SS, CELF EV, BPVS-3, LC, APT Information) and dropped APT grammar score variable. Both pre-test and post-test latent variables were constructed applying similar approach and were assessed for model (see Appendix tables F1 to F4) using the following criteria: root mean square error of approximation (RMSEA) <0.08; standardized root mean square residual (sRMR) <0.08; comparative fit index (CFI) ≥0.90; and Tucker-Lewis index (TLI) ≥0.95 (Hu and Bentler, 1999; Kline, 1998). The fit indices for both pre and post-test latent variables are shown in the Appendix F. The latent variables (pre-test, post-test) constructed using CFA model in MPlus (analysis code provided in appendix H) were then extracted to be used in MLM for effect size estimations. Furthermore, a sensitivity analysis was performed through creating a pre-test latent variable that used raw scores (CELF SS, CELF EV, BPVS-3, LC, APT Information) instead of standardised scores used in the main analysis; and also creating a post-test latent variable using raw scores for the language screen sub-items.








Appendix O: Distribution of secondary outcome variables




Appendix figure O1. Distribution of secondary outcome LanguageScreen Expressive Vocabulary scores




Appendix figure O2. Distribution of secondary outcome LanguageScreen Receptive Vocabulary scores




